**AGREEMENT FOR SUPPLY AND INSTALLATION OF COMPUTER & EQUIPMENT FOR  
AADHAR ENROLMENTS**

This agreement is made on the 01 day of December, 2015 between Madhya Pradesh State Electronics Development Corporation Limited, a Government of M.P. Undertaking incorporated under the companies Act, 1956 and having its registered office at 47-A, Arera Hills, Bhopal (hereinafter referred to as MPSEDC which expression shall, unless precluded or repugnant to the context include its successors and / or its assigns).

And

M/s Business Automation (I) Private Limited carrying out business at 110, Shalimar Corporate Centre 8, South Tukoganj, Indore (M.P.) In consideration of MPSEDC having placed/agrees to place Supply orders on 04th November, 2015 Hereby agrees and covenants as follows:

- 1 That the M/s Business Automation (I) Private Limited understood that time is the essence for present requirement of computers and equipments for Aadhaar enrolment by buyer departments/ organizations and agrees to supply computers /equipments (hereinafter referred to as goods) as per the L1 tender rate list and specifications enclosed herewith, to DeGS, any Government department or any other indenter on the terms and conditions specified in Tender no. MPSEDC/UID/2015/296. The said entire tender, technical specifications, terms and conditions, commercial offer, rate list, and all such correspondence taken place till date, shall form an integral part of this Agreement. Any other terms & conditions as may be mutually agreed upon shall also form part of this agreement.
- 2 The order will be placed directly by the buying department /organization as per approved rates and specifications.
- 3 That immediately after delivery and installation of the goods M/s Business Automation (I) Private Limited shall raise its bill on buyer department/ organization and present the same in duplicate together with the following documents.
  - Installation Report issued by the purchaser.
  - Receipt of goods supplied (Delivery challan)
  - Such other documents as may be prescribed by the user department specified in the tender / supply order.
- 4 Payment to the vendor will also be made by the department/ organization directly for the supplies as per the approved rates only. That on receipt of the bill and other documents from M/s Business Automation (I) Private Limited, buyer shall make payment to M/s Business Automation (I) Private Limited directly.
- 5 MPSEDC shall not be responsible for any delay or error or short payment on the part of the indenting/purchasing department in making the payment.
- 6 That M/s Business Automation (I) Private Limited shall be authorized to supply material directly to DeGS, any State Government/Semi-Government Organization at MPSEDC rate contract rates.
- 7 That EMD submitted will be retained as performance security by MPSEDC till the warranty period. No interest will be paid by MPSEDC. in case of non-supply or delayed supply or any other violation of this agreement (including the terms & conditions contained in the tender rate list or
